- Every candidate is expected to attend every session in its entirety.
- We do realize that unforeseen circumstances might arise. The candidate may not miss more than twelve (12) hours without possible dismissal from the program. If a candidate misses more than twelve (12) hours and/or any of the three mandatory classes, a Participation Certificate will be awarded instead of a Graduate Certification at the end of the program.
- Arriving 15 minutes late or leaving 15 minutes early constitutes missing one (1) full hour.
- Attendance will be recorded. Each participant will be notified in writing of their total hours to date at the end of each month.
- The participant will be assigned "homework" during the course & is expected to fulfill the requirement by each deadline.
- The participant will be required to commit a minimum of eight (8) hours for a community service project to be determined by the class members at a later date.

### FINANCIAL OBLIGATION

- If accepted to the class and your completed application arrives **on or before August 1, 2008**, Chamber member tuition fee is \$575 and non-member tuition is \$850. Successful applicants will be selected and notified by August 8, 2008. *Tuition must be paid in full by September 1, 2008.*
- If accepted to the class and your completed application arrives **after August 1, 2008**, tuition of \$675 for Chamber members and \$950 for non-members must be paid by September 1, 2008.
- Any payment made after September 1, 2008 will be returned to you and will forfeit your candidacy. The open spot will be offered to the first alternate.
- Tuition covers scheduled meals, transportations, overnight accommodations and other program expenses.
- Miscellaneous personal expenses must be borne by the candidate.
- Partial scholarships may be available. Please contact the Chamber office for more information.

### DEADLINES

- Completed application must be in Chamber office by 5:00 pm on August 1, 2008 to be considered in the selection process.
- If admitted to the class, tuition must be paid in full by September 1, 2008.

### AGREEMENT
